# 1. Indoor sports facilities HOUSE RULES SPORTS HALL [location name]

Dear visitor,

Welcome! To make your stay as pleasant and safe as possible, we would like to draw your attention to the following house rules.

#### 1. GENERAL

- 1. These house rules apply to every user who is in and around the sports hall. The provisions of the general and specific rental conditions apply insofar as these regulations do not explicitly deviate from them.
- 2. This sports hall is managed by [SRO Amersfoort BV / SRO Leusden BV / SRO Bunschoten BV / SRO Kennemerland BV / SRO Zeist BV / SRO De Bilt BV / SRO Huizen BV / SRO Velsen BV / SRO Stichtse Vecht BV] ("SRO").
- 3. A copy of these house rules is available at the cash register or reception.

#### 2. FOLLOW-UP OF RULES OF CONDUCT

- 4. These house rules and the instructions of SRO and/or persons working for it or engaged by it must always be followed.
- 5. Visitors who do not comply with the house rules and/or instructions of SRO and/or persons working for it may be requested to leave and are obliged to leave without refund of already paid entrance fees. Serious and/or repeated violations will result in denial of access to the sports hall for a shorter or longer period.

#### 3. GENERAL

- 6. You enter the sports hall at your own risk.
- 7. You must behave in the sports hall in such a way that you do not pose a danger to yourself and/or other visitors.
- 8. Intimacies (unwanted and desired) are not allowed.
- 9. It is not allowed to cause inconvenience to other visitors and/or staff. Any form of verbal and/or physical violence towards other visitors and/or staff is prohibited.

- 10. Smoking, use of soft and hard drugs and/or excessive alcohol consumption is prohibited throughout the accommodation.
- 11. For the safety of visitors, camera registration is used.
- 12. Bicycles and motorised vehicles (mopeds, scooters, e-bikes) must be placed in the designated bicycle shed and not in front of the entrance to the accommodation.
- 13. Waste must be deposited in the designated waste bins.
- 14. Animals are not permitted in the sports facility, with the exception of assistance dogs.
- 15. By entering this accommodation you agree to abide by the house rules that apply here. In the event of a criminal offence, the police will be called at all times.

#### 4. USE OF SPORTS HALL

- 16. The tenant is entitled to use the rented hall or the rented part of the hall, including changing rooms and the first aid room.
- 17. The tenant has the right to use the sports equipment present in the accommodation. You must provide small sports equipment such as balls, ribbons, rackets, shuttles, etc. yourself.
- 18. Equipment and other materials must be returned to their designated locations. Emergency exits must remain clear.
- 19. It is possible to use the changing rooms 10 minutes before the start of the rental time. After the rental time you must leave the changing rooms and showers within 20 minutes.
- 20. Sports equipment must be moved correctly to prevent damage to the sports floor.
- 21. It is not permitted to offer consumer goods for sale in the accommodation, unless other arrangements have been made with the landlord or tenant.
- 22. It is not permitted to prepare and/or consume meals in any of the premises and/or rooms made available.
- 23. Comments and remarks regarding the accommodation can be noted in the logbook provided.

- 24. It is not permitted to enter the hall with sports shoes that are also worn on the street or whose soles may leave marks.
- 25. The tenant must ensure a good hall guard. One must adhere to the hired time, including set-up/dismantling and clearing away of materials.
- 26. Glassware is not permitted in the stands, in the hall or in the changing rooms.
- 27. Spectators are expected to take a seat in the stands.
- 28. The use of resin and/or other adhesives is not permitted.
- 29. The tenant is obliged to comply with relevant laws and regulations.
- 30. SRO is not responsible for loss, damage and/or theft of property and/or physical injury in and around the buildings

#### 1. GENERAL

- These house rules apply to every user who is in the swimming complex. The
  provisions of the general and specific rental conditions apply insofar as they are not
  explicitly deviated from in these regulations.
- 2. This swimming pool is managed by [SRO Amersfoort BV / SRO Leusden BV / SRO Bunschoten BV / SRO Kennemerland BV / SRO Zeist BV / SRO De Bilt BV / SRO Huizen BV / SRO Velsen BV / SRO Stichtse Vecht BV] ("SRO").
- 3. A copy of these house rules is available at the cash register or reception.
- 4. In addition to these house rules, the protocol "Code of Conduct Swimming Pools" applies, as agreed between the regional swimming pools and the police. A copy of these Code of Conduct Swimming Pools is available at the cash register or reception.

#### 2. FOLLOW-UP OF RULES OF CONDUCT

- 5. These house rules and instructions of SRO and of persons working for it or engaged by it must always be followed.
- 6. Visitors who do not comply with the house rules and/or instructions of SRO and/or persons employed by it and/or the Swimming Pool Code of Conduct may be requested to leave and are obliged to leave without refund of paid entrance fees. Serious and/or repeated violations will result in denial of access to the swimming pool for a short or longer period.

#### 3. GENERAL RULES

- 7. Intimacies (unwanted and/or desired) are not allowed in this pool.
- 8. It is not allowed to cause inconvenience to other visitors and/or the pool staff. Any form of verbal and/or physical violence towards other visitors and/or the staff is prohibited.
- 9. Smoking, use of soft and hard drugs and/or excessive alcohol consumption is prohibited.

- 10. Animals are not permitted in the sports facility, with the exception of assistance dogs.
- 11. Visitors must behave in the swimming pool in such a way that they do not pose a danger to themselves and/or other visitors.
- 12. For the safety of visitors, camera registration is used.

#### 4. USE OF POOL

- 13. Visitors may only use the swimming pool if they are in good health and physically able to swim. Visitors with a physical condition, such as epilepsy, must report to one of the SRO supervisors in advance and swim with an attendant. Medical data is treated confidentially by SRO.
- 14. Children and/or visitors who do not have a swimming certificate and/or sufficient swimming skills, are only allowed access under the supervision of a person aged 18 or older who has a swimming certificate and sufficient swimming skills. Children who do not have a swimming certificate must always wear swimming armbands.
- 15. Children using buoyancy aids or other aids may only be in the deep pool under supervision during free swimming. Children with swimming wings may not go down the slide alone.
- 16. Swimming is only permitted in swimwear. Changing must take place in the designated changing rooms. Fathers must go to the men's changing room with their son or daughter. Mothers must go to the women's changing room with their son or daughter.
- 17. Transfer of children for (swimming) lessons takes place in the manner indicated by SRO. The parent(s)/guardian(s) accompany their child to the swimming instructor. At the end of the lesson, the swimming instructor also transfers the children to the parent(s)/guardian(s) at the same location.
- 18. Showering before entering the swimming water is mandatory. When using the sauna, you must adhere to the hygiene rules for using the sauna, which can be read there.
- 19. It is not permitted to enter the swimming hall and/or the wet footway at the changing rooms with shoes. Overshoes are for sale at the cash register or reception.
- 20. In the swimming hall it is not allowed to run or to bring fragile or dangerous objects. No drinks or food may be consumed in or near the water.
- 21. Visitors are not allowed to be in or near the changing room facilities without a valid reason.
- 22. Shore diving is only permitted at water depths greater than 2.00 metres.

- 23. Visitors must adhere to the rules of use of the slides, as shown on the signs at the slides.
- 24. Taking photos and/or video recordings in the pool is prohibited. SRO can grant a (collective) exemption from this prohibition for certain matters.

#### **5. RISK AND LIABILITY**

- 25. The use and stay in the swimming pool and the use of the materials therein are at the visitor's own expense and risk.
- 26. Visitors must store valuables and clothing in the designated lockers. Use of these is at your own risk. SRO is not liable for damage caused by theft and/or loss of property unless the damage is caused by intent or deliberate recklessness of SRO managers.
- 27. SRO's liability for damage and/or injury of any nature whatsoever, including bodily injury, is limited to a maximum of Euro 5,000.00 for property damage and Euro 25,000.00 for personal injury, unless there is intent or deliberate recklessness on the part of SRO staff.

- 4. In addition to these house rules, the protocol "Policy Code of Conduct for Swimming Pools" applies to the swimming pool, as agreed between the regional swimming pools and the police. A copy of these Policies of Conduct for Swimming Pools is available at the cash register or reception.

- 16. By entering this accommodation you agree to abide by the house rules that apply here. In the event of a criminal offence, the police will be called at all times.

#### 4. SPECIFIC RULES FOR THE POOL

- 17. Visitors may only use the swimming pool if they are in good health and physically able to swim. Visitors with a physical condition, such as epilepsy, must report to one of the SRO supervisors in advance and swim with an attendant. Medical data is treated confidentially by SRO.
- 18. Children and/or visitors who do not have a swimming certificate and/or sufficient swimming skills, will only be allowed access under the supervision of a person aged 18 or over who has a swimming certificate and sufficient swimming skills. Children who do not have a swimming certificate must always wear swimming armbands. An EasySwim lesson suit, life jacket or corks are not a substitute for swimming armbands.
- 19. Children using buoyancy aids or other aids may only be in the deep pool under supervision during free swimming. Children with swimming wings may not go down the slide alone.
- 20. Swimming is only permitted in swimwear. Changing must take place in the designated changing rooms. Fathers must go to the men's changing room with their son or daughter. Mothers must go to the women's changing room with their son or

daughter.

- 21. Transfer of children for (swimming) lessons takes place in the manner indicated by SRO. The parent(s)/guardian(s) accompany their child to the swimming instructor. At the end of the lesson, the swimming instructor also transfers the children to the parent(s)/guardian(s) at the same location.
- 22. Showering before entering the swimming water is mandatory. When using the sauna, you must adhere to the hygiene rules for using the sauna, which can be read there.
- 23. It is not permitted to enter the swimming hall and/or the wet footway at the changing rooms with shoes. Overshoes are for sale at the reception or cash register.
- 24. In the swimming hall it is not allowed to run or to bring fragile or dangerous objects. No drinks or food may be consumed in or near the water.
- 25. Visitors are not permitted to be in or near the changing and/or shower facilities without a valid reason.
- 26. Shore diving is permitted at a water depth of 2.00 metres or deeper.
- 27. You must adhere to the rules of use of the slide, as shown on the signs at the slide.
- 28. Taking photos and/or video recordings in the pool is prohibited. SRO can grant a (collective) exemption from this prohibition for certain matters.
- 29. You must store valuables and clothing in the designated lockers. Use of these is at your own risk. SRO is not liable for damage caused by theft and/or loss of property unless the damage is caused by intent or deliberate recklessness of SRO staff.
- 30. SRO's liability for damage and/or injury of any nature whatsoever, including bodily injury, is limited to a maximum of Euro 5,000.00 for property damage and Euro 25,000.00 for personal injury, unless there is intent or deliberate recklessness on the part of SRO staff.
